What?

We are thankful for a donor willing to match the annual total of any new monthly donations, up to \$10,000. This means that a \$100/month recurring donation (totalling \$1200 annually) will be matched with a one-time donation of \$1200!

Why?

Predictable monthly support is vital to ensure we have sufficient funds to cover all the regular monthly expenses of Kanada House and CMJ Canada. At present, monthly donations cover 25% of the monthly needs.

How does this match offer work?

- Only new monthly donations qualify for this match offer.
- Any increase to an existing monthly donation qualifies for the match.
- Multiply the new monthly amount by 12 to determine the total amount which will be matched
 - For example, @ \$50/month x 12 = \$600. This will be matched with a one-time donation of \$600!
- To receive the full match offer of \$10,000, CMJ Canada would need to receive new monthly commitments of: \$25/month from 3 people, \$50/month from 3 people, \$100/month from 3 people, \$150/month from 2 people, or any combination thereof.
- All monthly amounts are appreciated – no amount is too small!
- There are however processing fees and credit card fees which make it more cost effective to give:
 - via credit card for donations under \$40/month, and
 - via Pre-Authorized Debit (PAD) from your financial institution for donations over \$40/month.

- E-transfers are NOT eligible for a tax receipt.
